Almahdi Aluminium Co. (AAC) intends to sell and export **4,000 MT** Aluminium Sows A7 - P1015 (AL99.75%) and/or A8 - P0812 (AL99.80%) based on FCA Seller's Warehouse, Bandar Abbas, Iran according to the following conditions:

Explanatory Notes:

1- Subject: Export of 4,000 MT Aluminium Sows A7 - P1015 (AL99.75%) and/or A8 - P0812 (AL99.80%).

2- Introduction letter: All Bidders should send copies of their Introduction, Statute, Resume and Commercial License together with Bid Guarantee in the Envelope marked "**A**".

3- Shipment: July - August 2026 after (each) Payments.

4- Bid's Price: Bids must be **filled** as per **attached format** on Bidder's official letter-head and signed by authorized signatory in a sealed and stamped envelope marked "**B**".

Proposals will be considered **valid for 2 months** after closing date.

Unit Price proposed by Almahdi is in USD/ MT **only** and the other Currencies/Proposals will be rejected.

5- Delivery Term: FCA (Free Carrier) Seller's Warehouse, Bandar Abbas, Iran
All other terms and conditions stated in the draft of contract are confirmed by the seller.

6- Payment term: 100% Cash in advance shall be made according to Seller Payment Instructions in favor of Almahdi and/or third party against Proforma Invoice.

7- Bid Guarantee: The amount of **bid guarantee is 405,000,000,000 IRR (\$ 277,376.00)** which is paid to the following account. The bid guarantee can be provided in the form of an extendable Bank Guarantee which must be valid for 2 months after Closing date and extendable for 3 months or SAYAD Cheque handed over by Iranian Agent of Seller together with SAYAD System registration and confirmation. The bid guarantee is to be presented with the bidder's Introduction, Statute, Resume and Commercial License, inside the envelope marked. Bids with invalid bank guarantee / SAYAD Cheque without registration and confirmation or Iranian Friday & Holidays due date will be rejected **and also without letter of introduction of Iranian Agent of Seller** will be rejected.

If the Bidder wins and fails to perform; the entire amount of the guarantee will be Seized and Almahdi is allowed to pursue other legal processes in order to compensate for further losses and damages.

If the Bidder is going to hand over SAYAD Cheque via **Iranian Agent**, in the letter of introduction of the bidder, it should be clearly mentioned that the **Iranian Agent** accepts all the Bidder's obligations arising from the tender and authorizes the Bidder to refer to the provided guarantees. Also, the Bidder is also obliged to introduce the **Iranian Agent** and Cheque as a guarantee of his obligations to the Buyer through a declaration.
